Progress Energy Carolinas Commercial Solar Photovoltaic (PV) Program Application Form

INSTRUCTIONS:

- A. Prior to submitting a program Application, all Applicants must submit an Interconnect Request with Progress Energy Carolinas (PEC), with non-refundable processing fee, <u>AND</u> register the facility as a <u>New Renewable Energy Facility</u> with the North Carolina Utilities Commission (NCUC).
 - For systems located in North Carolina; see the North Carolina Interconnection Procedures by clicking here.
 - For systems located in **South Carolina**; see the South Carolina Interconnection Procedures <u>here</u>. Note that SC Interconnection Procedures are currently limited to systems up to 100 kW systems. However, all SunSense projects are required to submit a fully completed request form, but only systems up to 100 kW must include a processing fee.
- B. The Applicant will receive a notification upon PEC's receipt of a complete Interconnection Request. **Once received, the Applicant may complete the SunSense Application and attach the following prerequisite information:**
 - 1. A copy of the email notification of receipt of a complete Interconnection Request as provided by Progress Energy Carolinas Distribution Interconnection Department;
 - 2. The NCUC docket number associated with the registration as a New Renewable Energy Facility. This docket status must indicate that the registration has received acceptance as a New Renewable Energy Facility;
 - 3. For third party system ownership a completed and signed <u>Property Owner Authorization Form</u>;
 - 4. For third party system ownership a fully executed and binding letter of commitment, rooftop lease (or sublease) agreement, or other similar written authorization from the third party fee owner(s) of, and any Persons having a leasehold interest in the building (or specific portion thereof), as the case may be, upon which or where the Facility is located, which evidences said fee owner(s) and such other Person(s) written permission and authorization to use said building (or specific portion thereof) to construct, operate, and use the solar PV facility for a minimum term of 20 years;
 - 5. A fully executed and binding letter of commitment for full project financing from an equity investment group or bank, or statement of self-funding; and
 - 6. A copy of the installer's quote with itemized list of solar PV system components.

An Application may be submitted for one (1) rooftop mounted PV system with a maximum capacity of 500 kW (DC), to be located at a premise that currently does not host a solar array. The Application must be accompanied by all prerequisite information.

Applications submitted without all applicable prerequisite information will be deemed incomplete and will be declined. A declined Applicant must wait 30 days before re-submitting an Application.

Commercial Solar Photovoltaic (PV) Program Application Form

Eligibility: Only businesses, organizations, institutions, or government agencies served by Progress Energy Carolinas, Inc. ("PEC") are eligible to apply. The Applicant must own the solar PV system ("System") and all non-energy attributes of the System, including environmental attributes and/or the renewable energy certificates ("RECs") attributable to the amount of energy generated by the System.

System Requirements: The System must be: (1) installed on real property owned by a non-residential customer of PEC, located in North Carolina or South Carolina, (2) between 11 kW (DC) and 500 kW (DC) nameplate capacity, (3) installed <u>after January 1, 2012 (and after PEC and Applicant have signed a binding Program Contract</u>), and (4) interconnected and metered according to PEC's Small Generator Interconnection process. The full electrical output of eligible systems, along with the associated RECs, will be sold to PEC.

Contract and Approval: PEC, in its sole and absolute discretion, may accept, accept with conditions, or reject any application for any reason. Upon PEC's acceptance of an application, PEC will notify the Applicant and provide the Applicant with a Program Contract, on PEC's standard form. The Applicant must sign and return the form Program Contract to PEC for PEC's signature, together with a W9 Form. If System installation occurs before a Program Contract is signed by both the Applicant and PEC, then PEC may, in its sole and absolute discretion, determine that the Applicant's System is ineligible for the Program. In such event, PEC shall have no obligation to make any Program payment to Applicant.

Payment Terms: Applicant will receive \$0.15/kWh for the System Energy and RECs for a period of 20 years, subject to Program acceptance and Applicant's compliance with all terms, conditions, and obligations of Applicant specified in the Program Contract.
