- Air Sealing/Insulation Contractors, please remember to put the TOTAL number of square footage that was sealed and insulated – not the amount qualifying for the incentive.
- Heat Pump Water Heaters If you are an installer and not currently on our prequalified list, please let your Area Representative know so that you can get trained.
- HVAC –The program provides incentives for HVAC replacements, duct repair/replacement, insulation with air sealing, HVAC audits, heat pump water heaters and ENERGY STAR® window air conditioners.
- HVAC replacements and duct systems No limits on the systems that can be replaced or repaired providing that they

- meet all program eligibility requirements. Remember: sealing duct boots to the floor is required.
- Window A/C units Limited to four ENERGY STAR units.
